COVID-19 Testing Update

Beginning this week, our weekly COVID testing program will be moving to individual testing in place of the pool testing that is currently in place. There is no change to the actual testing process, so students and staff won't notice a difference. Currently, up to

ten swabs are pooled together when sent to the lab for processing - should a "pool" come back positive, each of these individuals would be retested individually. This testing program, sponsored by the U.S. Department of Health and Human Services, will now provide for individual testing, which will eliminate the potential need for retesting students in the event of a positive pool result.
