# Data, Tools and Resources Utilized to Evaluate our Timeline for Transitioning to In-Person Instruction

- ELPS is monitoring health data for the county and East Lansing Community daily. We are
  also in communication with MSU and the Ingham County Health Department on a regular
  basis. As part of the Extended Continuity of Learning Plan, the district is required to
  consider the following metrics:
  - COVID-19 Cases or Positive COVID-19 tests
  - Hospitalizations due to COVID-19
  - Number of deaths resulting from COVID-19 over a 14-day period
  - o COVID-19 cases for each day for each 1 million individuals
  - The percentage of positive COVID-19 tests over a 4-week period
  - Health capacity strength
  - Testing, tracing, and containment infrastructure with regard to COVID-19
